## **COST**

- The entry fee is \$125 per team.

#### **AWARDS**

- A plaque will be awarded to the schools that finish in 1st, 2nd, and 3rd place.

#### **TOURNAMENT RULES**

- Pool play will consist of two 25-point rally-scored games, with each game starting at 4-4.
- In pool play, a team must win by two, with a 30-point cap on each set.
- Championship games will be best two-of-three sets with no cap.

#### **TIEBREAKERS**

Should a tie of win/loss record within pool play occur, the following procedures in this order will determine placement in the championship, third place, and consolation matches:

- 1. Head-to-head results in games played between the tied teams
- 2. Point differential between the tied teams using only games played against one another
- 3. Point differential of the tied teams involving all games played in pool play
- 4. Should a tie still remain, one set to 15 will be played with a 17-point cap.

#### **LINE JUDGE**

- Each school must provide a line judge for each match.

#### **LOCKER ROOMS**

- Locker rooms will be available, but all valuables are the responsibility of each team.

#### **ADMISSION**

- Admission for the tournament will be \$5.00 for adults.
- K-12 students, kids under 5, and senior citizens (65+) are admitted free of charge.

#### WARM-UP PROCEDURES

- Each team will be allowed a 5-5-1 shared warm-up time for their first match only.
- The shared warm-up time will start as soon as possible after the first match.
- The shared warm-up time clock will start as soon as the previous match has concluded.
- After the first game, teams will share a 3-3-1 minute warm up.
- Practice balls will be provided. Please see that your players keep balls in the gym.

### **CONCESSIONS**

- Concessions will be offered throughout the day.
- There will be a hospitality room for coaches, officials, bus drivers, and administrators.
