The **District Staff Health Fair** is scheduled for Thursday, April 25, at Russellville High School. The following partners are scheduled to attend the health fair: Sam B. We are very grateful for the generous donation of their time and resources.

#### Priority Area #3 (Funding/Facilities)

Fiscal Year 2023-2024 Expenditure Budget amended to \$12,097,137.68. \$211,983.70 less from preliminary budget.

- Superintendent's Goal: between -2% to +2% of actuals. According to SISFIN, as of 3/23/2024, we are projected to be over the amended budget by \$805,969 However, this is due to unusually high spending in our 6500s because of our bond project. We are projected to spend \$362,834 under budget (excluding 6500s). I believe this is a more accurate projection.
- Salaries (6100's)- \$60,000 under the preliminary budget. Highlighted reasons: Unanticipated full-time employee changes throughout the year.

• Benefits (6200's)- \$5,000 under the preliminary budget. Highlighted reasons: Unanticipated full-time employee changes throughout the year.

• Purchase Services (6300's)- \$2,832.50 over the preliminary budget. Highlighted reasons: Energy audit

• Supplies (6400's)- \$84,182.00 over the preliminary budget. Highlighted reasons: Portion of safety grant, football uniforms, 1411s historical spending.

• Capital Projects (6500's)- \$233,998.20 under the preliminary budget. Highlighted reasons: We spent \$190,998.20 on our bond project last fiscal year.

Fiscal Year 2023-2024 Revenue budget amended to \$9,100,043.58. \$157,895.30 more from preliminary budget

• Superintendent's Goal: between -2% to +2% of actuals. According to SISFIN, as of 3/23/2024, it is projected to be \$571,325 under the amended budget. I believe this is because we still have several grants that we have been approved for but have not yet been awarded.

• Local Revenue (5100's)- \$12,118.72 over the preliminary budget. Highlighted reasons: student activity accounts historical data

• County Revenue (5200's-)- \$1,000 under the preliminary budget- Highlighted reasons: Historical data

• State Revenue (5300's)- \$70,401 over the preliminary budget. Highlighted reasons: safety grant, historical data.

• Federal Revenue (5400's)- \$51,375 over the preliminary budget. Highlighted reasons: energy audit grant, historical data

#### **Potential District Grant Writing Team:**

Susie Epperson, founder of Grants 4 Schools Network, has agreed to do a 6-hour workshop for our district. I attended her Grants 4 Schools Conference a few months ago. It was very informative on ways to secure funding for schools. We will have applied for over 1 million dollars of additional grant funding by the end of this school year. I believe we can increase this amount for next year and feel there is a need for additional resources for our staff and students. This service would cost the district \$2,250. This workshop would be available for anyone who is interested in helping our district secure additional funding. #### **Temporary Construction Easement with the City**

A temporary easement will be in effect during the time of construction of an updated drainage system, and related improvements along the sides of the easement area, and for the following purposes: the right to enter upon, and permanently re-grade and re-slope the easement area; resurface the easement area, and any other construction required for the purpose of improving the drainage quality throughout and around the easement area; and to store materials, operate and park equipment on, over and across the easement drainage area on the southwest side of the basketball court. The basketball court is located southwest of the softball field, which is located southwest of Russellville Elementary School.

#### Elementary softball field 1-year lease with the City

The Premises shall be used for all such purposes reasonably related to use by the Lessee's baseball, softball, and archery programs, including, but not limited to, practices and competitions. As such, the Parties agree that the Premises shall be accessible to Lessee's staff, students, parents, and others in connection with baseball, softball, and archery practices and competitions.

#### High School Addition Bond Construction Project Update:

The following are notes from construction meeting on 3/8/24:

• The masons have installed the brick veneer, window stone sills and washed down the brick. The masons will need to come back and address several locations on the brick veneer. The painters have installed two finish coats on the walls, and they will need to come back and paint the sprinkler room and the hollow metal door frames. The ceiling grid is installed in the classrooms and roughly 90% in the hallways. The electricians have installed the classroom and hallway lights. The flooring is installed in the classrooms.
