## **Priority Area 1: Teaching & Learning**

#### CKLA Curriculum Fully Implemented (Grades K-6)

## **Priority Area 3: Funding & Facilities**

#### Raising the Base Salary - In Motion

We've taken bold steps toward our salary goal, raising the base from \$34,000 to \$37,000 and securing a \$40,000 minimum for certified staff.

Looking forward, our long-term roadmap for step 10 with a masters degree is as follows:

- •\$47,000 in 2026–2027
- •\$48,000 in 2027-2028

#### CTE Grant Awarded – \$61,250 for Hands-On Learning

Thanks to the leadership of **Nathan Strobel** and **Ellen Romero**, we received the **Vocational-Technical Education Enhancement Grant**, unlocking over **\$43,000** in state funds for:

- Welding, plumbing, and electrical tools
- •CNC Shark and propane forge
- Food science and woodshop equipment

These investments directly support our students' career and technical skill development in agriculture, industrial tech, and food science.

#### **Facility & Program Enhancements**

#### **New High School Gym Floor completed**

**New Elementary Playground** – Supported by the Scrap Tire Grant, installation of the new playground equipment is scheduled to be completed before the first day of school.

**Expanded Pre-K Program** – Our pre-K students attended school tuition-free in 2024–2025 through the MOQPK Grant. We've reapplied for 2025–2026!

We would like to extend a huge thanks to our facilities team! Your work behind the scenes makes a massive impact on learning environments!

#### New Missouri School Safety Law - SB 68

Signed by Governor Kehoe, Senate Bill 68 (effective August 28) includes key provisions for:

- Emergency response planning
- Anti-intruder door locks
- Stop the Bleed kits
- Active shooter & CPR training
- Behavioral risk assessments

We will provide training and updates as needed.

#### IMPORTANT REMINDERS from the Nurse Christie Murphy, RN

Following are some reminders for the 2025-2026 school year affecting certain grade levels and all students due to current Missouri state laws.

8<sup>th</sup> Grade: Tdap and MCV4 Vaccinations: Tdap (tetanus booster with pertussis) and MCV4 (Meningococcal in the form of Menactra or Menveo) vaccines are required for students enrolled in 8<sup>th</sup> grade. The deadline to submit proof of Tdap and MCV4 vaccines is the 1<sup>st</sup> day of school in August. If your child needs this immunization, contact your physician or clinic. Once he/she receives the Tdap and MCV4, please forward a copy of the official record from your health care provider to the school office. The vaccines may also be received at the Cole County Health Department. Bring your child's immunization record with you. For more information, their phone number is 573-636-2181.

12th Grade: MCV4 vaccinations (2 doses): Two doses of MCV4 (Meningococcal in the form of Menactra or Menveo) are required for students enrolled in 12<sup>th</sup> grade. If the first dose was administered at age 16 years or older, then only one dose is required. The deadline to submit proof of MCV4 vaccines is the 1<sup>st</sup> day of school in August.

<u>Kindergarten Immunizations:</u> A current and updated immunization record must be provided to the school before they can attend. The final set of vaccinations that Kindergarten enrollees must receive **after** their 4<sup>th</sup> birthday and before entering Kindergarten include: another Dtap, polio, a 2<sup>nd</sup> MMR, and a 2<sup>nd</sup> Varicella (chickenpox) vaccine. If the child has had chickenpox disease, proof of disease must be provided in the form of a written statement signed by a physician documenting the month and year the child had chickenpox. Parental verification is not accepted. Immunizations can be obtained through the child's physician or by appt. at the Cole Co. Health Dept. For more information, call 573-636-2181.

<u>Preschool Immunizations:</u> A current and updated immunization record must be provided to the school before they can attend.

<u>District-wide Medication policy reminder for all grades:</u> Medication must be delivered to and picked up from school by a parent or designated adult. Long-term daily prescription medications given during school hours require a written physician authorization with pharmacy-labeled container. **New authorization is required for the new school year even if there was no change to your child's prescription.** If the dosage changes during the school year, an updated authorization is also required. Additional rules to the medication policy are in the school handbooks. For clarification, call Christie Murphy at 782-4814.

Student health history forms: In August, your child will bring home a new Student Health Information form. All students **must** return this form each school year. Please ensure that the pain reliever and cough drop permission line is marked according to your preference to be administered to your child as needed from the nurse's supply.

<u>Food substitutions:</u> If your child will require food substitutions due to a medically diagnosed condition, a specific form entitled "Medical Statement for Student Requiring Special Meals" will need to be completed by their physician. Copies of the form are available in the school nurse's office or on the school website. Note: \*This form must be in place before dietary accommodations can be made.

#### PUBLIC RELEASE

#### July 2025

<u>Cole County R-I School District</u> announced its revised free and reduced price policy for school children unable to pay the full price of meals served in schools under the National School Lunch Program and the School Breakfast Program.

Local education officials have adopted the following family-size income criteria for determining eligibility:

Children from families whose current income is at or below those shown are eligible for free or reduced price meals. Applications are available at the school office. To apply, fill out a Free and Reduced Price School Meals Family Application and return it to the school. The information provided on the application is confidential and will be used only for the purpose of determining eligibility. Applications may be submitted any time during the school year. A complete application is required as a condition of eligibility. A complete application includes: (1) household income from all sources or Food Stamp/TANF case number, (2) names of all household members, and (3) the signature and last four digits of social security number or indication of no social security number of adult household member signing the application. School officials may verify current income or other information provided on the application at any time during the school year.

Foster children may be eligible regardless of the income of the household with whom they reside. Households with children who are eligible under the foster, Head Start, homeless, migrant, or runaway programs should contact the school for assistance in receiving meal benefits. Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) participants may be eligible for free or reduced price meals.

Children who are members of households currently certified as receiving Food Stamps, TANF or FDPIR are eligible for free meals. To complete an application, the household must provide the names of the children, a statement that the household receives the qualifying benefits, the Food Stamps/TANF/FDPIR case number, and the signature of the adult household member making application. When known by the school that members of a household are receiving assistance from Food Stamps, TANF or FDPIR, households will be notified of their children's eligibility for free school meals. If any children in the household were not listed on the eligibility notice or not listed on the application, the household should contact the school to have benefits extended to all children in the household.

If a family member becomes unemployed or if family size changes, the family should contact the school to file a new application. Such changes may make the children of the family eligible for these benefits.

Under the provisions of the policy, the Central Office Administrative Assistant will review the applications and determine eligibility. If a parent is dissatisfied with the ruling of the determining official, they may wish to discuss the decision with the hearing official on an informal basis or he/she may make a request either orally or in writing to the Superintendent. Hearing procedures are outlined in the policy. A complete copy of the policy is on file in each school and in the central office where any interested party may review it.

#### **USDA Non-discrimination Statement:**
