- 6. SB 727 mandates all school districts in Missouri must have a base salary of \$40,000 and teachers on step 10 w/Masters degree to be paid \$48,000 per year by the school year 2025-2026. That means if the state does not provide a \$40,000 baseline salary grant, we must have a base salary of \$40,000
