#### • Contents:

Proposals must include:

- Supporting documentation
- Certifications and warranties
- Technical specifications
- Pricing, schedule, and scope of work
- Any other pertinent information
- Validity: All proposals must remain valid for a minimum of thirty (30) days after submission deadline.
- Other Requirements:
  - Incomplete, late, or faxed proposals will not be accepted.
  - Proposals are final and binding upon submission—no amendments will be accepted after submission.
  - The District reserves the right to reject any or all proposals, accept any proposal in the District's best interest, or enter into negotiations with any bidder regarding pricing or terms.

#### Amendments to the RFP

The District may issue amendments or clarifications prior to the proposal deadline. Any changes will be shared with all registered vendors via official **addenda**, which will take precedence over the original RFP content. Addenda will typically be issued at least **three (3) days** before the proposal deadline.

# Scope of Work

Contractor shall provide all labor, materials, equipment, and permits to complete asphalt paving for the following five (5) locations:

# 1. Elementary School Parking Lot

Current Condition: Gravel/chat surface

Required Work: Full asphalt paving

# 2. High School Parking Lot

Current Condition: Concrete surface

• Required Work: Asphalt overlay

# 3. Football Field and Track Access Drive & Parking Lot

Current Condition: Gravel/chat surface

Required Work: Full asphalt paving

#### 4. Baseball/Softball Complex (125 feet by 125 feet)

Current Condition: Gravel/chat surface

Required Work: Asphalt paving with curb

### 5. Parking Area Across from Elementary

Current Condition: Grass surface

Required Work: Asphalt paving with curb

#### Legal Description:

Part of the Southeast Quarter of the Northeast Quarter of Section 3, Township 43 North, Range 14 West, in the City of Russellville, Cole County, Missouri, more particularly described as follows:

Beginning at an iron stob located on the north line of Park Street and the west line of Smith Street in the City of Russellville, Missouri; thence north along the west line of Smith Street a distance of 100 feet; thence west 127 feet, more or less, to the northeast corner of an adjoining tract and also being on the west line of another referenced tract; thence south along the west line of said tract a distance of 100 feet to the north line of Park

Street; thence east along the north line of Park Street, 127 feet, more or less, to the point of beginning.
