Request for Proposals (RFP)

The proposed price shall be good for a period of at least one hundred twenty (120) days from the submittal date. Cole County R-1 School District reserves the right to refuse any and all bids and to waive any technicalities and formalities. Cole County R-1 School District reserves the right to negotiate with all qualified offerors and reserves the right to cancel this solicitation in part or its entirety if it is in the best interest of the District to do so. Any agreement for services is subject to board approval.
